

## End-of-Sale and End-of-Life Announcement for the Cisco SPA2102 Single Port Router with 2 Phone Ports

Cisco announces the end-of-sale and end-of-life dates for the Cisco SPA2102 Single Port Router with 2 Phone Ports. The last day to order the affected product(s) is September 10, 2014.
